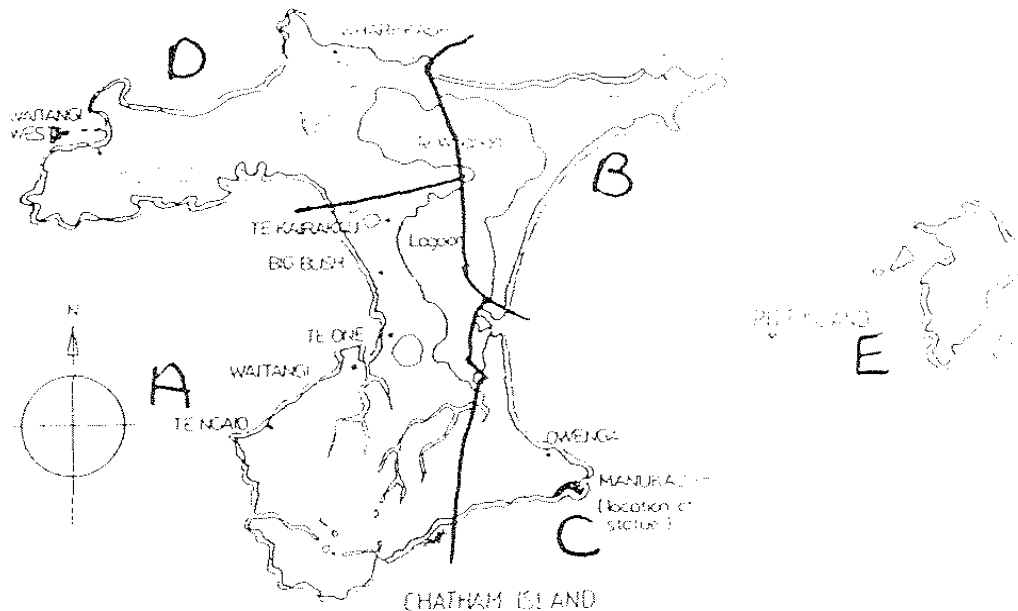

Chatham Islands Area Map

Function: To assist the Local Controller to establish control in the area through reconnaissance, reporting and providing leadership and guidance to the community. The Island has been divided into 5 areas with Area Coordinators appointed for each area.



Area A

All that area of Chatham Islands west of and including the Te Awainaga River, Taupeka Point in the north, south of the Chatham Lodge and including Karewa Airport and Te Whanga.

Area B

All that area east of Taupeka Point and north of Hikurangi channel including Te Whanga.

Area C

All that area south of Hikurangi channel east of the Awainaga River and Makara River.

Area D

All that is west of the Chatham Lodge bounded by The Whanga and including Port Hutt and Waitangi West.

Area E

All of Pitt Island.
